S.O. In exercise of the powers conferred by sub-section (2) of the section 11 of the Indian Medical Council Act, 1956(102 of 1956), the Central Government, after consulting the Medical Council of India, hereby makes the following further amendments in the First Schedule to the said Act, namely:-

In the said First Schedule against "Maharashtra University of Health sciences, Nasik, Maharashtra" under the heading 'Recognized Medical Qualification' [in column (2)] and under the heading 'Abbreviation for Registration'[in column (3)], the following shall be inserted, namely:-

Bachelor of Medicine and Bachelor of Surgery	M.B.B.S. (This shall be a recognized medical qualification when granted by Maharashtra University of Health sciences, Nasik, Maharashtra, in respect of students being trained at Dr. Ulhas Patil Medical College, Jalgaon, Maharashtra on or after December, 2012 with annual intake of 100 students per year.
