Ragging

As per Medical Council of India (Prevention and Prohibition of Ragging in Medical Colleges/Institutions) Regulations, 2009 :-

Sec.4. Punishable ingredients of Ragging:-

- Abetment to ragging;
- Criminal conspiracy to rag;
- Unlawful assembly and rioting while ragging;
- Public nuisance created during ragging;
- Violation of decency and morals through ragging;
- Injury to body, causing hurt or grievous hurt;
- Wrongful restraint;
- Wrongful confinement;
- Use of criminal force;
- Assault as well as sexual offences or even unnatural offences;
- Extortion;
- Criminal trespass;
- Offences against property;
- Criminal intimidation;
- Attempts to commit any or all of the above mentioned offences against the victim(s);
- Physical or psychological humiliation.
- All other offences following from the definition of "Ragging".

5. Awardable Punishments.

8.1 At the Medical College/Institution level:

Depending upon the nature and gravity of the offence as established by the Anti-Ragging Committee of the institution, the possible punishments for those found guilty of ragging at the institution level shall be any one or any combination of the following:

- 8.1.1 Suspension from attending classes and academic privileges.
- 8.1.2 Withholding/withdrawing scholarship/ fellowship and other benefits
- 8.1.3 Debarring from appearing in any test/ examination or other evaluation Process.
- 8.1.4. Withholding results.
- 8.1.5 Debarring from representing the institution in any regional, national or international meet, tournament, youth festival, etc.
- 8.1.6 Suspension/ expulsion from the hostel.
- 8.1.7 Cancellation of admission.
- 8.1.8 Rustication from the institution for period ranging from 1 to 4 semesters.
- 8.1.9 Expulsion from the institution and consequent debarring from admission to any other institution for a specific period.
- 8.1.10 Fine of Rs. 25,000/- to Rs. 1 lakh.
- 8.1.11 Collective punishment: When the persons committing or abetting the crime of ragging are not identified, the institution shall resort to collective punishment.

RAGGING



Ragging is strictly prohibited. Ragging is defined as any act which causes or is likely to cause physical or psychological harm or cause apprehension to the new student whether by words, spoofs, teasing, shouting, playing practical jokes on the new student or by any act or to perform the onerous chore willingly to do so is and indirectly involved or abetting in ragging is expelled/suspended from the institution and the Supreme Court of India decision on 19th February, 1987. No one can take anyone or the 1987 those who engage in ragging can be punished for six months to 10 years & fine up to Rs. 50,000.

Ragging in any form is a punishable offence. Supreme Court directions regarding ragging in educational sector may also be referred to. The Institute Administrators may take appropriate action under the following provisions:

Actions to be taken against students in technical institutions/Universities including technical educational institutions:

- The punishment to be meted out to the offender(s) should be exemplary and justifiably harsh to act as a deterrent.
- Every single incident of ragging is a crime and should be reported to the institutional authority.
- Depending upon the nature and gravity of the offence, the Ragging Committee of the institution, if constituted, should file a report to the following:
 - Cancellation of admission
 - Suspension from attending classes
 - Withholding/withdrawing scholarship
 - Debarring from appearing in an examination
 - Withholding results
 - Debarring from representing the institution in any regional, national or international meet, tournament, sports event
 - Suspension/expulsion from the institution
 - Expulsion from the institution and/or any other institution
 - Fine of Rupees 25,000
 - Collective punishment, when the perpetrators are not identified, the institution should ensure community participation along with actions taken to the effect of such incident and inform the status of the case to the concerned authority.
- Courts should make an effort to ensure that the punishment to be meted out to the offender(s) should be exemplary and justifiably harsh to act as a deterrent.
