







**Issue No.5.: Biannual online report to be submitted to MUHS.**

In our college Dr. Ulhas Patil Medical College Jalgaon, Our next academic session is commencing on **01 March 2023**, prior to that it is necessary to have a communication and dialog between all of us i.e you, your ward, and college authorities, regarding the anti ragging Act's provisions and the punishments thereto.

As all of us know that, today the ragging is becoming the curse and menace to our society. In order to prevent the ragging the college has taken every step to prevent ragging in the college premises and campus. The college has totally banned the ragging in all its forms in the entire Medical College/ Institution including its departments, constituent units, all its premises (academic , residential, sports, canteen, hostel, library etc.) to root out ragging.

We are hereby by appealing you that, kindly resist your ward from indulging in ragging activities, when they come back at the beginning of the next academic session i.e 2020-2021.

We are hereby informing you certain important provisions regarding ragging and punishments of the Maharashtra Prohibition of ragging act, 1999 and Medical Council of India (Prevention and Prohibition of ragging in medical college/Institutions) Regulations, 2009.

Medical Council of India (Prevention and Prohibition of Ragging in Medical Colleges/Institutions) Regulations, 2009:-

**A – Rule 3.3:- Ragging" includes the following:**

Any conduct whether by words spoken or written or by an act which has the effect of harassing, teasing, treating or handling with rudeness any other student, indulging in rowdy or undisciplined activities which causes or is likely to cause annoyance, hardship or psychological harm or to raise fear or apprehension thereof in a fresher or a junior student or asking the students to do any act or perform something which such student will not in the ordinary course and which has the effect of causing or generating a sense of shame or embarrassment so as to adversely affect the physique or psyche of a fresher or a junior student.

The above sub-clause 3.3 shall be substituted in terms of notification published on 28.03.2016 in the Gazette of India with the following:

**"Ragging" includes the following:**

Any conduct whether by words spoken or written or by an act which has the effect of harassing, teasing, treating or handling with rudeness any other student, indulging in rowdy or undisciplined activities which causes or is likely to cause annoyance, hardship or psychological harm or to raise fear or apprehension thereof in a fresher or a junior student or asking the students to do any act or perform something which such student will not in the ordinary course and which has the effect of causing or generating a sense of shame or embarrassment so as to adversely affect the physique or psyche of a fresher or a junior student. The conduct includes but is not restricted to any act by a senior student that prevents, disrupts or disturbs the regular academic activity of any other student or a fresher; exploiting the services of a fresher, or any other students for completing the academic tasks assigned to an individual or a group of students; any act of financial extortion or forceful expenditure burden put on a fresher or any other student by students; any act of physical abuse including all variants of it: sexual abuse, homosexual assaults, stripping, forcing obscene and lewd acts, gestures, causing bodily harm or any other danger to health or person; any act or abuse by spoken words, emails, post, public insults which would also include deriving perverted pleasure, "vicarious or sadistic thrill from activity or passively participating in the discomfiture to fresher or any other students; any act that affects the mental health and self-confidence of a fresher or any other student with or without an intent to derive a sadistic pleasure or showing off power, authority or superiority by a student over any fresher or any other student.

**Sec. 4. Punishable ingredients of ragging:-**

**Punishable ingredients of Ragging:-**

- Abetment to ragging;
- Criminal conspiracy to rag;
- Unlawful assembly and rioting while ragging;
- Public nuisance created during ragging;
- Violation of decency and morals through ragging;
- Injury to body, causing hurt or grievous hurt;
- Wrongful restraint;
- Wrongful confinement;
- Use of criminal force;
- Assault as well as sexual offences or even unnatural offences;
- Extortion;
- Criminal trespass;
- Offences against property;
- Criminal intimidation;
- Attempts to commit any or all of the above mentioned offences against the victim(s);
- Physical or psychological humiliation.
- All other offences following from the definition of "Ragging".

**Sec. 8:- Awardable Punishments.**

**At the Medical College/Institution level:**

Depending upon the nature and gravity of the offence as established by the Anti-Ragging Committee of the institution, the possible punishments for those found guilty of ragging at the institution level shall be any one or any combination of the following:

- 8.1.1 Suspension from attending classes and academic privileges.
- 8.1.2 Withholding/withdrawing scholarship/ fellowship and other benefits
- 8.1.3 Debarring from appearing in any test/ examination or other evaluation Process.
- 8.1.4. Withholding results
- 8.1.5 Debarring from representing the institution in any regional, national or international meet, tournament, youth festival, etc.
- 8.1.6 Suspension/ expulsion from the hostel
- 8.1.7 Cancellation of admission.

8.1.8 Rustication from the institution for period ranging from 1 to 4 semesters

8.1.9 Expulsion from the institution and consequent debarring from admission to any other institution for a specific period.

8.1.10 Fine of Rs. 25,000/- and Rs. 1 lakh.

8.1.11 Collective punishments: When the persons committing or abetting the crime of ragging are not identified, the institution shall resort to collective punishment.

**Maharashtra Prohibition of Ragging act, 1999**

**Sec.2 (c) "ragging" means** display of disorderly conduct, doing of any act which causes or is likely to cause physical or psychological harm or raise apprehension or fear or shame or harassment to a student in any educational institution and includes -

- i) teasing, abusing, threatening or playing practical -jokes on, or causing hurt to, such student; or
- ii) asking a student to do any act or perform something which such student will not, in the ordinary course, willingly, do.

**Sec.(4) Penalty for ragging:-** Whoever directly or indirectly commits, participates in, abets or propagates ragging within or outside any educational institution, shall, on conviction, be punished with imprisonment for a term which may extend to two years and shall also be liable to a fine which may extend to ten thousand rupees.

**Sec.(5) Dismissal of Student:-** Dismissal of student Any student convicted of an offence under section 4 shall be dismissed from the educational institution and such student shall not be admitted in any other educational institution for a period of five years from the date of order of such dismissal.

**Sec. (6) Suspension of student:-**

1 . Whenever any student or, as the case may be the parent or guardian, or a teacher of an educational institution complains, in writing, of ragging to the head of the educational institution, the head of that educational institution shall, without prejudice to the foregoing provisions, within seven days of the receipt of the complaint, enquire into the matter mentioned in the complaint and if; prima facie, it is found true suspend the student who is accused of the offence, and shall, immediately forward the complaint to the police station having jurisdiction over the area in which the educational institution is situated, for further action.

2. where, on enquiry by the head of the educational institution, it is proved that there is no substance, prima facie, in the complaint received under sub-section(1), he shall intimate the fact, in writing, to the complainant.

3. The decision of the head of the educational institution that the student has indulged in ragging under sub-section (1), shall be final.

You are hereby requested to inform, instruct, and warn your ward to desist/ not to indulge in ragging activities, so as to prevent legal consequences against them.
